

PRIVACY STATEMENT

Dear Customer,

We hereby inform you that, in accordance with section 13 of Italian Legislative Decree No. 196 of 2003, the processing of the information you provided during registration on this website is for the purpose of collecting data for the dispatch/shipping and billing of your order. Should you not give the information, the order will not be carried out.

CASA PLAVE (AZ. AGRICOLA LORIS CECCHETTO) undertakes to treat such data as confidential and not to disclose them to unauthorised persons or use them for other than the stated purposes unless you give your explicit permission to do so in the specified forms. Such data may be communicated, after signing a confidentiality agreement, to outside workers and employees assigned to data storage and to carrying out the above activities and will be distributed solely within the scope of the purposes of the service provided. Such data may be shown upon request by the authorities authorised to see them by law.

The data controller and processor of your personal data is: CASA PLAVE (AZ. AGRICOLA LORIS CECCHETTO), with registered office in Via Risera 33 – San Polo di Piave (Treviso).

CASA PLAVE (AZ. AGRICOLA LORIS CECCHETTO) informs you forthwith that in order to provide certain services it uses companies in its confidence, which carry out tasks of a technical or organisational nature on its behalf. These companies work directly with Casa Plave and process the data in the capacity of data processors.

With regard to the processing of your personal data, you may exercise your rights directly as per section 7 of Italian Legislative Decree No. 196 of 2003, including and in particular to obtain information concerning:

- the source of your personal data;
- the purposes and methods of processing;
- the logic applied in the case of processing carried out with the aid of electronic tools;
- details of identification of the data controller, data processors and designated representative pursuant to the second paragraph of section 5;
- persons or categories of persons to whom the personal information may be disclosed or who may have knowledge thereof in their capacity as designated representative within the territory of the State, as data processors or persons in charge of processing.

You are also entitled to have:

- such data updated, rectified or, when so interested, completed;
- such data erased, transformed into an anonymous form or blocked with regard to information processed unlawfully, including information whose retention is unnecessary for the purposes for which it was collected or subsequently processed.

You are entitled to object, in whole or in part:

- on legitimate grounds, to the processing of the personal information that relates to you, even if pertinent to the purpose of the collection;
- to the processing of personal information that relates to you for the purpose of sending advertising material or of direct sales or for carrying out market research or business communications.
